**WAIVER AND ASSUMPTION OF RISK AGREEMENT**

**New Application or Renewal**

**As a condition of being a participant of any activity on JCSSA property, all members are required to sign this Participant Waiver and Assumption of Risk Agreement. The participant shall hereafter be referred to as “Undersigned” and by signing this agreement, he/she agrees to the following:**

In consideration of being permitted entry to and/or presence on **JCSSA’s** range, buildings, facilities and land (together comprising “Premises”) including but not limited to the **Undersigned’s** use of firearms and/or other weapons, including but not limited to: crossbows, longbows, BB guns and air rifles by him/her and/or another, and with full knowledge that firearms and/or other weapons are used and discharged on **JCSSA** premises, the **Undersigned** agrees to indemnify, hold harmless and defend **JCSSA** from any and all fault, liabilities, costs, expenses, claims, demands, and/or lawsuits arising out of, related to, or in any way connected with any and all alleged acts or omissions of the **Undersigned** in the course of **Undersigned’s** presence on and/or use of **JCSSA’s** premises.

The **Undersigned** further waives for himself/herself and for his/her heirs, next of kin, assignees, personal representatives, administrators and executors of any and all rights and claims for damages, loss, costs, demands and any other actions or claims whatsoever, which he/she may have or which may arise against **JCSSA** (including, but not limited to, damage to **Undersigned’s** property and/or any and all illnesses, injuries, including emotional distress or anguish, and other damages, including death, suffered by the **Undersigned**) which may in any way whatsoever arise out of or be related to, or be connected with the use of firearms and/or any other weapons on **JCSSA** Premises by the **Undersigned** and/or another.

The **Undersigned**, on behalf of himself/herself and on behalf of his/her heirs, next of kin, assignees, personal representatives, administrators and executors, expressly releases **JCSSA** and **JCSSA’s** members, employees and/or agents from any and all such claims and liabilities, including but not limited to, claims of actual or alleged negligence (excluding gross negligence) on the part of **JCSSA**, it’s members employees and/or agents.

The **Undersigned** acknowledges and agrees that the use of firearms and/or other weapons is an inherently dangerous activity and the **Undersigned** expressly assumes the risk of being on **JCSSA** Premises where firearms and other weapons are used and the **Undersigned** further assumes the risk of discharging firearms and the use of any weapons by whomever and the firing of live ammunition and use of any weapons by himself/herself and/or another. The **Undersigned** also assumes full responsibility and liability for any/all non-member guests he/she may bring on the premises.

The **Undersigned** expressly agrees that this agreement by him/her is intended to be as broad and inclusive as permitted by law and that if any provision of this agreement is held invalid or otherwise unenforceable; the enforceability of the remaining provisions shall not be impaired. No remedy conferred by any of the specific provisions of this agreement is intended to be exclusive of any other remedy and each and every remedy shall be cumulative and all be in addition to every other remedy now and hereafter existing at law or in equity or by statute or otherwise. The election on any one or more remedies hereunder by **JCSSA** shall not constitute any waiver of **JCSSA’s** right to pursue other available remedies. This agreement binds the **Undersigned** and his/her heirs, next of kin, assignees, personal representatives, administrators and executors.

The **Undersigned** acknowledges and agrees that the **Undersigned** has read this agreement and he/she understands its terms and is executing this agreement voluntarily. The **Undersigned** also acknowledges and agrees that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and procedures as stated by **JCSSA**.
